## Andrew McLaughlin

Andrew is a leading barrister with a national practice in the fields of personal injury, industrial disease and clinical negligence. His focus on client service and enviable ability to turn paperwork around quickly and efficiently has seen him develop into one of the busiest barristers in the country.

Andrew is ranked as a Tier 1 barrister in The Legal 500 for personal injury and Band 1 in Chambers UK for personal injury and industrial disease for which he is ranked as a national expert in the Spotlight Table. Andrew is regularly instructed as a leading junior on cases where silks have been instructed on the other side. Notably, in 2021 he comprehensively defeated a well-known KC in the case of *Walkden v Drayton Manor Park*, securing a finding of fundamental dishonesty. The claim was originally pleaded at £1.6m.

Matthew routinely deals with all aspects of personal injury litigation for both claimants and defendants.

Matthew has a particular interest in “pain cases”: those involving conditions of uncertain aetiology and/or subjective pain without commensurate physiological basis. Recent cases have included substantial (£1m+) together with more modest claims arising from many diagnoses: fibromyalgia, chronic fatigue syndrome (ME), functional neurological disorder, functional cognitive disorder, chronic pain syndrome, somatoform pain disorder/ bodily distress disorder, and complex regional pain syndrome.
